MEF' Repurchase agreements (Repo) activity Updating of the Portfolio

The Ministry of Economy and Finance (MEF) announces an update of the securities portfolio, to be used exclusively in Repo operations. With settlement date the **17th of July 2023**, through an ad hoc issue, 5 new tranches of government bonds have been added to replace the same number of tranches which will be cancelled with the same settlement date - two of which with a residual maturity of less than 6 months.

As announced in the inaugural Press Release of May 17, 2021¹, the Repo operations are a tool among the instruments in use within the cash management activities carried out by the Treasury.

A regular update of the own portfolio, as highlighted in the press release mentioned above, is deemed appropriate to give the Treasury the opportunity to intervene on the secondary market of government bonds to improve its liquidity.

As already happened in the previous portfolio updates, the issued amount of each BTP is equal to 1,000 million euro for each of the pre-selected lines. As a result of these new changes, the total amount of the securities portfolio aimed exclusively at Repo operations remains unchanged and is equal to 45,000 million euro.

The detailed list of securities tranches cancelled, as well as the complete new list of securities in the portfolio, are displayed in the tables annexed to this announcement.

The securities included in the aforementioned portfolio will not contribute to the formation of public debt until they are not employed in Repo transactions.
